

Torus Competition Rules March 2022

Torus Competition Rules

The following rules shall apply when entering a competition with Torus62 Limited and its Subsidiaries (referred to below as Torus) together with any instructions or rules specific to any current competition.

By entering any of our competitions, you are deemed to have accepted the following:

 Only one entry per household. Multiple entries will be discounted. Entrants must be over the age of 18.

Under 18s will only be allowed to enter in circumstances whereby the competition is expressly opened to that age group.

- 2. The competitions are free to enter and to qualify for and be entered into any of our competitions you must be a Torus tenant (or entering on behalf of a tenant) and not subject to a live Notice Seeking Possession.
- 3. Prizes must be accepted as offered; no alternative prize or cash will be awarded. Prizes do not include the cost of travel or any other associated costs.
- 4. The competitions are not open to Torus employees and their relatives, and anyone professionally connected with the prize offered in this competition. Torus reserves the right to verify the eligibility of all entrants.

- 6. By taking part in the competition, you warrant that all information submitted is true, current and complete at the time of submission. It is your sole responsibility to ensure that your details and e-mail address are accurate, and that Torus is informed of any changes to these. Torus accepts no responsibility for any changes which are not properly notified from the time of submission of your entry to the time of notification that the prize has been awarded.
- 7. Any entries received after the closing date or not complying with the terms and conditions will be disqualified.
- 8. All entries will be considered the property of Torus and will not be returned.
- Winners will be confirmed within one month of the closing date. The closing date is as specified in the competition. Please allow 28 days from successful notification for delivery of any prizes. Failure to claim a prize within the time or in the manner specified may result in disqualification and the selection of an alternative winner.
- 10. By entering a competition, you agree to being involved in any publicity should you win a prize.
- 11. Any personal data provided by entering the competition will be used in accordance with the UKs Data Protection Legislation (from time to time). Please see the <u>Privacy Policy</u> for further details.
